1. Introduction: about ProCESS

ProCESS addresses the lack of training in the field of complexity management which leads to the underperformance of many organisations and the weakening of the people within these organisations.

ProCESS aims to:

- 1. Develop a methodology to deal with complex management cases through alternating sequences of mobilisation of Sensory, Emotional, and Spiritual (SES) intelligences, in addition to rational capacities;
- 2. Test this methodology on real business cases;
- 3. Train new types of trainers (philosophers, artists, architects,..) in SES Skills and develop a new niche of activity for them;
- 4. Transpose this methodology into existing bachelor and master degree programmes as well as lifelong/vocational training programmes.

Over 3 years, ProCESS involved 192 students from France, Romania, Finland and Latvia, who were coached by academic and company coaches from 4 universities and 4 companies, and by SES Skills trainers. ProCESS' new training approach aims at improving agility in decision making of current and future managers for more performance, giving rise to new teaching profiles/fields, and leading to sustainable changes in management habits and more well-being at work.

ProCESS was organized in 7 work packages:

- 1. WP1-Project coordination
- 2. WP2- Preparing the company cases and building the ProCESS training modules
- 3. WP3- Analysing 12 complex management cases through the ProCESS method
- 4. WP4- Pilot trainings at partner HEIs, partner companies, associate partners and other interested parties
- 5. WP5- Quality assurance
- 6. WP6 Evaluating ProCESS results and impacts
- 7. WP7- Disseminating and exploiting ProCESS results
